

## Irrigation System and Landscape Water Efficiency Program

### 1. Sign up for a free Irrigation and Landscape Assessment

This is a basic assessment of residential and commercial irrigation systems and landscapes that will assess your irrigation system and landscape and provide recommendations on how to make it more water efficient. Sign up online at [ourwatermatters.ca](http://ourwatermatters.ca)

### 2. Waterwise Landscape and Climate-Based Irrigation Controller Rebate

#### 2A. Waterwise Landscape Rebate

The waterwise landscape component of the program will provide a \$250 rebate on waterwise plants, mulch and/or soil amendments with good quality compost providing that \$500 or more is spent by the homeowner and 50% of the landscape is replaced with waterwise materials. - Sign up for a free assessment. Staff from the Irrigation Industry Association of BC will do an assessment and prequalify your landscape for a rebate.
- If approved, after the assessment purchase plants, compost and mulch and send the invoice along with the completed application in Schedule A to [iiabc@irrigationbc.com](mailto:iiabc@irrigationbc.com). While Spring is the most popular time for gardening projects, the best time to establish a waterwise landscape is in the Fall.
- A minimum 50% of total landscape area must be improved using waterwise landscape material to qualify for the rebate.
- Plants that are purchased must be water wise and non-invasive. Native plants for the Fraser Valley climate are the best choice. The nursery you purchase from must sign off on your receipt stating that the plants are waterwise and non-invasive. You can find a list of plants that would qualify at these sites: <http://www.growgreenguide.ca/> and <http://fraservalleyconservancy.ca/gardening-guide/>.
- If a compost soil amendment is being applied for, the minimum thickness of the soil amendment for turf areas is 200 mm. For gardens and bed areas the minimum depth must be 400 mm.
- The homeowner will forward the completed application form in Schedule A along with proof of invoice payment for the plant material, mulch and/or compost to [iiabc@irrigationbc.com](mailto:iiabc@irrigationbc.com).
- Budget is limited, so the rebate is based on first come, first serve basis.
- An inspection may be required of the completed site prior to payment being made. **Application deadline for rebate is October 31 and work must be completed by November 30.**

## 2B. Climate-Based Irrigation Controller Rebate

A \$250 rebate is available for the installation of a climate-based irrigation controller when installed by a Certified Irrigation Contractor.

- Sign up for a free assessment. Staff from the Irrigation Industry Association of BC will assess your irrigation system and will prequalify your system for a rebate.
- If approved, contact a certified contractor. Companies listed on the IIABC website that have a Certified Irrigation Scheduler on staff will be considered to be approved contractors. A list of approved contractors in the Lower Mainland is shown in Schedule B.
- Once the controller has been installed the homeowner will forward the completed application form in Schedule C along with proof of payment for the controller to [iiabc@irrigationbc.com](mailto:iiabc@irrigationbc.com)
- Budget is limited, so the rebate is based on a first come, first serve basis.

An inspection may be required of the completed site prior to payment being made. **Application deadline for rebate is October 31 and work must be completed by November 30.**
